PRIVACY NOTICE

Pursuant to the Article 13 of Regulation (EU) 2016/679, on the protection of natural persons with regard to the processing of personal data and on the free movement of such data, (hereinafter, also only "GDPR") below, we hereby provide you the privacy notice relating the processing of your personal data that will be carried out by Rucellai&Raffaelli Law Firm for the virtual conference "Antitrust between EU law and national law", that will be held on 29 October 2020 (hereinafter also only the "Event").

1. DATA CONTROLLER

2. CATEGORIES OF PERSONAL DATA PROCESSED

As part of the Event, the following personal data will be processed, provided by you directly at the time of registration for the Event: name and surname, e-mail, company, phone number, fiscal code, Italian Bar Association.

3. PURPOSES OF THE PROCESSING OF PERSONAL DATA AND LEGAL BASIS

Your personal datawill be processed by R&R for the following purposes.

3.1. Registration and participation at the Event

Your personal data will be collected in order to:

- allow you to register and participate in the Event organized by R&R;
- create and subsequently manage the registry of the participants at the Event;
- communicate your personal data and data on your participation at the Consiglio Nazionale Forense for the purpose of providing CLE credits.

The **legal basis** of the processing of personal data for the purposes referred to in paragraph 3.1 above is the **legitimate interest** of R&R to promote its business and to constantly inform old and new customers about its services. The legitimate interests of the Data Controller are not overridden by the interests or fundamental rights and freedom of the data subject.

3.2. Promotional activity of R&R

Your personal data will be processed for promotional activities - through automatic tools (email, fax, sms and mms) or traditional tools (phone calls with operator, paper mail) - by R&R such as:

- all activities, including advertising and promotional activities, connected and related to the Event;
- sending newsletters, brochures, catalogues, presentations;
- sending commercial and/or promotional communications of information, in-depth analysis and/or updating in relation to R&R services;
- invitations to special events promoted inside and outside R&R also abroad;
- studies and market research.

The **legal basis** of the processing of personal data for the purposes referred to in paragraph 3.2 above is your **previous specific consent**.

4. OBLIGATORY OR OPTIONAL NATURE OF THE SUPPLY OF YOUR PERSONAL DATA - CONSEQUENCES OF ANY REFUSAL

- **4.1** The provision of your Personal Data for the purposes referred to in paragraph 3.1 above is optional, however, failure to provide such personal data will result in the impossibility to register and participate in the Event.
- **4.2** The provision of your personal data for the purposes set out in paragraph 3.2 is optional and failure to provide it will have no effect on the possibility of participating in the Event, but it will result in the impossibility of informing you about promotional and commercial initiatives and sending you invitations to events. We also point out that if you have given consent to authorize the Data Controller for the purposes referred to in paragraph 3.2, you will remain free at any time to withdraw consent and / or to object the processing of personal data for the aforementioned purposes and/or methods, by clicking on the link found in any e-mail you receive from R&R or by sending a clear written communication to the contact details specified in paragraph 9 " *Contact to exercise your rights and for further information*" which follows.

5. MODALITIES OF THE PERSONAL DATA PROCESSING

Your personal data will be processed using manual, informatic, telematic and paper tools in compliance with current legislation, so as to guarantee security and confidentiality even in the case of execution. The personal data you provide will not be subject to fully automated decision-making processes.

6. PERSONAL DATA'S RECIPIENTS

The recipients of your personal data and as well as the subjects who will be able to know your personal data will be:

- (i) persons appointed for processing by R&R to whom specific instructions have been provided in writing:
 - Conference Secretariat
- (ii) subjects providing R&R services appointed by the latter in writing as data processor:
 - E&M Communication S.r.l., company providing the Cliniq Brand Surgery platform;
- (iii) other third parties who process personal data as independent data controllers:
 - Consiglio Nazionale Forense

For a complete and updated list of the subjects to whom the personal data are communicated, please write to R&R at the addresses indicated in the following paragraph 9 "Contact to exercise your rights and for further information".

7. PERSONAL DATA RETENTION

Your personal data will be retained:

- i) for the management of the Event: 2 years after the registration for the Event, except in cases where further conservation is justified by litigation and/or requests of the competent authorities;
- ii) for marketing purposes: 2 years after the registration of the R&R systems.

Your personal data will be stored on server of R&R, located in Italy, at Rucellai&Raffaelli Law Firm, and at Cliniq Brand Surgery – E&M Communication S.r.l.

8. RIGHTS OF DATA SUBJECT

Pursuant to articles 13, paragraph 2, letters b), c) and d) and 15-22 of the GDPR, we inform you that:

- a) You have the right to request **access** to your personal data as well as to the information regarding the purpose of processing, the category of personal data processed, the recipients or categories of recipients to whom the personal data have been or will be disclosed (in particular recipients in third countries or international organizations), where possible, the envisage period for which the personal data will be stored or, if not possible, the criteria used to determinate the period, the existence of your rights to request from the data controller rectification or erasure of personal data or restriction of processing of personal data concerning or to object to such processing, to your right to submit a complaint before a supervisory authority, at their source, the existence and the logic involved in case of automated decision-making. If you exercise this right unless your different indications you will receive an electronic copy of your personal data processed.
- b) You also have the right to obtain:
 - the **rectification** of your personal data, if they are inaccurate or incomplete;
 - ii. the **erasure** of your personal data, where there is one of ground of the art. 17 of GDPR (for example: your personal data are no longer necessary in relation to the purposes for which they were collected; you withdraw consent to the processing where this is the legal basis and there is no other legal grounds for the processing, you object to processing and there are no overriding legitimate grounds for the processing; the personal data have been unlawfully processed;
 - The **restriction** of processing of your personal data: 1) for a period enabling the Data Controller to verify the accuracy of your personal data (if the accuracy of the personal data is contested by you) or 2) if the processing is unlawful and you oppose the erasure of the personal data and request the restriction of their use instead; or 3) the Data Controller no longer needs your personal data for the purposes of the processing, but they are required by you for the establishment, exercise or defence of legal claims 4) for the time necessary to evaluate the possible prevalence of the legitimate reasons of the Data Controller with respect to yours, if you have objected to the processing of your personal data pursuant to point c below;
 - iv. your personal data in a structured, commonly used and machine-readable format also to transmit your personal data to another data controller where the processing is based on consent or is carried out by automated means (cd. right to **data portability**). If you want you have the right to have the Personal Data transmitted directly from Data Controller to another, where technically feasible.
- c) You have **right to object** to the processing of your data personal, if this processing is carried out pursuant to the art. 6.1 lett. e) (i.e. for the performance of a task carried out in the public interest vested in the Data Controller) or lett. f) (i.e. to pursue a legitimate interest of the Data Controller) of the GDPR, unless the Data Controller demonstrates compelling legitimate grounds for the processing which override the other interests, pursuant to the art. 21 of GDPR.
- d) You have the right **to withdraw consent** at any time, without affecting the lawfulness of processing based on consent before its withdrawal.
- e) If carried out, you have the right **not to be subject to a decision based solely on the automated processing**, including profiling, which produces legal effects concerning you or similarly significantly affecting you, also having the right the right to obtain human intervention on the part of the Data Controller, to express point of view and to contest the decision.
- f) If you are not satisfied of processing of your personal data carried out by Data Controller, you can **submit a complaint** to the Italian Data Protection Authority, following the procedures and the indications published on the official website of this authority. (www.garanteprivacy.it).
- g) Any corrections or deletions of your personal data or limitations on the processing performed upon your request unless this proves impossible or involves a disproportionate effort will be communicated by the Company to **each of the recipients** to whom your personal data may be transmitted in accordance with the present notice.

The exercise of the rights is not subject to any forms and is free of charge. The Data Controller can ask to you to verify your identity before undertaking further actions following your request.
